### **BRIEF DESCRIPTION**

Clinical Traineeship III: Mental Health is an external practice subject. # **PRACTICAL**

- The traineeships will be carried out in hospitals and affiliated units. The objectives will be:
  - Training of the student in the application of Occupational Therapy knowledge to patients diagnosed with mental illness.
  - Training of the student to be able to establish an adequate therapeutic relationship.
  - Development of communication skills, therapeutic planning.
  - Development of analysis capacity of the observation and practice carried out.
  - Use of group, recreational and intervention techniques to empower patients in activities of daily living.

### **EVALUATION**

- During the rotations, a evaluation of the competences will be carried out, which allows the numerical expression of the result, through the Portfolio, approved by the Faculty Board.
- The evaluation of the subject will be carried out through the qualification issued by the professors and collaborators of the centers and through the analysis of the Portfolio. The Portfolio will include the work done by the student, and the indications by the professor or collaborator of practices. It must reflect the attendance and availability of the student and the interaction with the assigned activity. This evaluation will be ratified by the coordinator of the subject.

The evaluation of the content of the Portfolios is based on:

On the one hand: attendance, punctuality, behavior and participation in the activity.

On the other hand, the following are valued:

- Theoretical-practical knowledge.
- Clinical and occupational skills.
- Communication skills.
- Interprofessional relations skills.
- · Ability to analyze problems.
- · Decision making.
- Attitudes in the performance of the professional activity.
- Ethical attitudes.

In accordance with the provisions of article 5 of Royal Decree 1125/2003, the results obtained by the students will be graded according to the numerical scale from 0 to 10, with the expression of a decimal.
