The psychosocial evaluation of adaptive skills includes the procedures aimed at assessing the psychosocial functioning of people and the contexts where they live and develop carried out in order to describe their main deficits, determine the components of the execution affected and collect data to verify the effectiveness of the proposed treatments.

It implies knowledge of the main psychosocial assessment techniques (interview, observation, objective tests, scales, questionnaires, etc.) that allow an assessment of the consequences that, in the functioning of affected people and their families and caregivers, have various health conditions associated with sensory, physical and mental disability.

PRACTICAL

Keynote sessions:

Oral presentation complemented with the use of audiovisual material and the introduction of some questions aimed at students, in order to transmit knowledge and facilitate learning.

Readings: set of texts and written documentation that have been collected and edited as a source of deepening of the contents worked.

Case studies: methodology where the student faces the description of a real problem of professional life and must be able to analyze a series of facts, referring to a particular field of knowledge or action, to reach a reasoned decision through a process of discussion in small work groups.

Activity laboratory: methodology that allows students to learn effectively through practical activities.

Cooperative learning: group work technique and public exposure during class.

Tutorials: supervision of learning and clarification of doubts regarding the subject.

EVALUATION CRITERIA

- **Individual test** with 20 objective test questions with three alternatives. **(60%)**.
- **Supervised practical work**: work developed in a group designated by the teacher with topics proposed by the same, from four to six components depending on the number of students in the general group. **(20%)**
- **A practice that will be carried out in pairs** related to the practical content of the subject **(20%)**
- **Theory and practices must be approved separately to make the sum of the final grade.**
